Policy Aims

We endeavor to:

Paper

We will minimise the use of paper in the office.

We will reduce packaging as much as possible.

We will seek to buy recycled and recyclable paper products.

We will reuse and recycle all paper where possible.

Energy and Water

We will seek to reduce the amount of energy used as much as possible.

Lights and electrical equipment will be switched off when not in use.

Heating and cooling will be adjusted with energy consumption in mind.

The energy consumption and efficiency of new products will be taken into account when purchasing.

Supplies

We will evaluate if the need can be met in another way.

We will evaluate the environmental impact of any new products we intend to purchase.

We will favour more environmentally friendly and efficient products wherever possible.

We will reuse and recycle everything we are able to.

Transportation

We will reduce the need to travel, restricting to necessity trips only.

We will make additional efforts to accommodate the needs of those using public transport or bicycles.

Maintenance and Cleaning

Cleaning materials used will be as environmentally friendly as possible.

We will only use licensed and appropriate organisations to dispose of waste.

Fire

No fires allowed in fire-sensitive habitats and vegetation.

No fires allowed in fire risk areas.

All fires to be monitored at all times and extinguished properly.

Only dead wood from ground is to be collected for firewood.

Existing fire pits are to be used where possible, otherwise minimal impact fires only and buried where possible.

All waste from cigarettes to be carried out

Petroleum and other flammable substances are not to be used when lighting fires

All vehicles carry a fire extinguisher

Rubbish

All rubbish is to be separated into general waste, recycling and compost, and carried out.

Toileting

Use facilities where possible, otherwise a 15cm deep hole will be dug to the level of the decomposition layer, and all waste deposited within.

All Paths are to be adhered to where possible.

Camping to be done on pre-existing sites and hardened areas where possible.

Flora and Fauna to be respected and not interfered with.

Group sizes to be kept small.

Monitoring and Improvement
